(1st time fresheners 3000#+) Animal ID#s are required (tattoos or scrapie numbers) Veterinarian will be available on grounds to provide health papers for all Iowa animals. Out of state breeders must have proof of negative T.B. Brucellosis test to sell reproductive animals. All bucks must come from a completely CAE free herd (See definition above). CSDG is not responsible for any errors or omissions in catalog printing. Commission: 7%. Penalty for no shows: \$25 / reg, \$15 / ind, \$10 / group; exceptions for death or disease only. Non-payment of no show fees could disqualify farm from future consignments.
