**Consignor Guidelines:** Bucks accepted at any age if healthy and structurally sound. Pedigrees should accompany bucks. No animals with visible abscesses accepted. Animals should be wormed prior to sale. Committee reserves the right to reject non-qualifying animals. Animal ID numbers are required (tattoos or scrapie numbers) Veterinarian will be available on grounds to provide health papers for all Iowa animals. Out of state breeders must have proof of negative T.B. Brucellosis test to sell reproductive animals. ADGA member will present pedigrees and make announcements. CSDG is not responsible for any errors in printing. Commission: 7% Penalty for no shows: \$25 / registered, \$15 / individual, \$10 / group; exceptions made for death or disease only. Non-payment of no show fees could disqualify farm from future consignments.
