Veterinarian will be available on grounds to provide health papers for all Iowa animals.

Out of state breeders must have proof of negative T.B. Brucellosis test to sell reproductive animals.

Commission: 10% - Penalty for no shows: \$25 / registered, \$15 / individual, \$10 / group; exceptions made for death or disease only.

Non-payment of no show fees could disqualify farm from future consignments.
